A commercial invoice is necessary and must cover duties/taxes which range from 5% to 40% of CIF value plus 12% of valued added tax.</b></li> <li><b>Used items will be assessed by customs taking into consideration prices listed in the packing list and subject to physical inspection.</b></li> </ul> <p>It is advised that insured values of the items DO NOT appear on the inventory or shipping manifest to enable maximum allowances for use factors.</p>	<p><b>Customs Inspection</b> Air, Sea and Land Freights : Shipments are cleared directly in a bonded warehouse under informal entry, providing the original documents for clearing the shipments and all shipments are subject to a physical inspection from customs authorities. This could take between 4 to 8 working days depending on the transportation mode and the size of the shipment. It is necessary to unload the containers and trailer trucks, prior to customs clearance because these cannot remain closed in the warehouse.</p> <p><b>Door-to-Door</b> Containers or trailer trucks could be cleared at bonded warehouse in Guatemala City, if customs authorities grant release and approve temporary entry. If an inspection takes place at the POE additional charges will be invoiced.</p> <p>Customs may require completing entry and paying taxes/duties directly at POE.</p>

Duties will be based on C.I.F. value as determined by Customs. Fumigation of imported wooden crates		<p>Guatemala Government adopted ISPM-15 (International standards for Phytosanitary Measures Publication 15) Guidelines for Regulating Wood Packaging Material in International Trade (aka NIFM-15) to standardise the treatment of wood packing materials used for the transport of goods.</p> <p>Shipments into or out of the country in wooden packaging, need to have a Seal, certifying that the shipment has received the required treatment (HT = Heated Treatment [a minimum wood core temperature of 56°C for a minimum of 30 minutes] or fumigation with Methyl Bromide (MT). The minimum temperature should not be less than 10°C and the minimum exposure time should not fall below 16 hours.</p> <p>The treatments established in the present regulation have the intent to reduce the introduction and/or the dissemination of quarantine</p>	<p>This regulation DOES NOT apply to wood packing materials manufactured of:</p> <ul style="list-style-type: none"> <li>• Raw wood of 6 mm thickness or less</li> <li>• Processed wood produced by glue, heat and pressure, or a combination thereof</li> <li>• Plywood sheets &amp; agglomerated sawdust sheet</li> <li>• Oriented wooden fibre sheets</li> <li>• Sawdust &amp; Wooden fibre</li> </ul>

Labels and adhesives are not allowed.
