

**General Remark: For the shipments of HHGS and personal effects between countries in European Union there are no customs formalities, starting with 2007, January 1st.**

This import is possible starting with the date from the Resident Permit but not more than 12 months after.</p> <p>Any person older than 15 years, who travels to Romania, is allowed to bring in exemption of duties and taxes goods with a value assessed by the customs, according to their tariffs for used personal effects, in amount of 175 EURO. For younger person this amount is 90 EURO.</p> <p>For what exceeds this value, duties and taxes are to be paid according to Customs Import Tariffs of Romania.</p> <p>Still, there are possibilities to import in Romania used personal effects in exemption of duties and taxes when a person with residence abroad who comes to work in Romania</p>	<p>Documents needed for importing a car: original registration card, sale certificate or invoice in original.</p> <p>Cars can be registered only if they comply with EUR 3 standard. Diplomatic cars are not affected by this regulation.</p>

If the Resident Permit is not available yet, If the Resident Permit is not available yet, a statement will be issued that client will obtain it within 6 months.</b></li> <li>- <b>The title of the residence in the name of the client or, at least, a 2 years minimum leasing contract.</b></li> <li>- <b>Legalized mandate for the moving company, to perform customs clearance (provided by the client, in Romania)</b></li> <li>- <b>Legalized statement of the client that the goods in the shipment belong to him for at least 6 months, that are not meant for commercial purposes but to furnish the secondary residence, that he won't lease the residence while he or his family are not in Romania and that he lived outside Romania for the last 12 months, (template provided by the moving company, in Romania).</b></li> </ul>	<p><b>If all these documents are available, the client will have a temporary import in exemption of duties and taxes for the goods needed to furnish the residence (usual exclusions: alcohol, stupefians, fire guns, cigars and cigarettes...). This import is possible starting with the date from the Resident Permit. This facility is granted for one residence and a single transport, only. THEREFORE, THE CUSTOMS OFFICER WILL WRITE IN THE ORIGINAL PASSPORT OF THE CLIENT THE REGISTRATION NUMBER OF THE APPROVAL.</b></p>	<p>No vehicules, motorcycles, small plains, small boats can be included in the shipment.</p>

This import is possible starting with the date from the legacy certificate but not more than 2 years after. Vehicles	Documents needed for importing a car: original registration card in the name of the client, sale certificate or invoice in original, VALIDE PLATES. Cars can be registered only if they comply with EUR 3 standard. Diplomatic cars are not affected by this regulation. PLEASE NOTE THAT FOR FOREIGNERS, CARS WILL NOT BE REGISTERED WITHOUT RESIDENT PERMIT.	<b>Starting with 2007, January 1st new fiscal regulations and charges for registration of second hand car will be implemented. To register a car in Romania (if complies at least with EURO 3 standards, otherwise is not possible) owner will have to pay ecological charge. This depends of age, engine capacity and type of fuel.
