

If shipment is by loose into FCL, please show CY-CY on the B/L.</p> <p>The following articles are prohibited from entry:</p> <ul style="list-style-type: none"> <li>• Counterfeit coins, security notes, banknotes, plates or dies for printing or casting forged currencies.</li> <li>• Gambling apparatus, lottery tickets and other similar prize tickets issued in foreign countries.</li> <li>• Obscene and indecent books, publications, pictures, articles, and videos.</li> <li>• Publications and articles propagating</li> </ul>

Any thing more than reasonable amount would subject import duty and tax.</p> <p>Above items must be used personal effects, and if new, should be removed from original box and repacked to avoid high duty.</p>	<p>communism.</p> <ul style="list-style-type: none"> <li>Any articles produced, manufactured or originated in Communist China, North Korea, Vietnam, Albania, Romania, countries of previous U.S.S.R. and Cuba.</li> <li>Weapons, arms and ammunition, cartridges, explosives, poisonous gas and other weapons of war.</li> <li>Opium, cannabis idica, cocaine and products, and other dangerous drugs.</li> <li>Toy guns, ornamental swords and knives.</li> <li>Articles infringing the rights of patents, of designs and trademarks, and the copyrights of other persons.</li> <li>Contraband articles as specified by other Laws. e.g. Fruits, vegetables and other foodstuffs coming from places prevailing with injurious pests and plant disease, and/or any animals and pets from an infected area.</li> <li>For furs, skins, ivory etc., from endangered species, shipper must get CITES approval before importation. If not these goods will be confiscated and the shipper will face prosecution.</li> </ul>

		Additional 5% VAT and 0.3% Harbour tax			<ul style="list-style-type: none"> <li>To avoid high demurrage charges, do not ship the car until import permit is obtained from Board of Foreign Trade if the car's value is over USD 20,000.00. If the car value is under the above value, an application for an import license from customs department is needed. The application takes 3 to 4 days</li> <li>Car import permit must be obtained and approved by Taiwan government agency.</li> <li>The car cannot be sent before the destination agent obtains the import licence in Taiwan.</li> <li>One car allowed per family. The car can be shipped with household goods in the same container. No belongings to be put inside the car.</li> </ul>

Dogs, Cats (from rabies area).	<ul style="list-style-type: none"> <li>• Import permit.</li> <li>• Photocopy of shipper's passport + photo page + signature page</li> <li>• <del>Residence certificate.</del></li> <li>• <del>Working certificate issued by Taiwan Government.</del></li> <li>• Origin certificates of Health and Rabies vaccination (with killed virus) from government or state sponsored agency. Date of the health certificate must be within 10 days before departure. Date of vaccination must be within more than one month and less than one year of departure.</li> </ul>	<ul style="list-style-type: none"> <li>• Need quarantine at least 21 days (Area of Rabies)</li> <li>• No quarantine for dogs &amp; cats (from area free of rabies) Japan, UK, Sweden, Australia, NZ, Iceland.</li> </ul>	<ul style="list-style-type: none"> <li>• Please notify the destination agent before you send the animal to Taiwan.</li> <li>• Animals should not be shipped to Taiwan before the destination agent obtains import permit.</li> <li>• Dogs and cats cannot be imported from Malaysia, China, and Singapore. Do avoid transfer pet shipment in these areas.</li> <li>• All dogs and cats shipped into Taiwan must have Microchip implanted. Birds	<ul style="list-style-type: none"> <li>• Certificate of No Fowl Pest, No Newcastle disease, No Psitta Casis, approved by the Department of Agriculture of Local Government.</li> </ul>	Quarantine of no more than 7 days in Taiwan.	Before sending the bird, please contact your agent for updated and additional information. Do NOT send the bird before your agent agreement.
<b>Wooden Packaging Materials</b>		<p><b>“Wooden packaging materials” (WPM) including pallets, dunnage, crating, packing blocks, drums, cases, load boards, pallet collars and skids which are used to load, to pack, mat, support or fix any good will need to be treated.</b></p> <p><b>WPM shall be treated under the supervision of the plant quarantine authority of the exporting country according to ISPM 15 (International Standards for Phytosanitary Measures No. 15).</b></p> <ul style="list-style-type: none"> <li>• <b>Methyl bromide (MB) fumigation</b></li> <li>• <b>Heat treatment (HT): WPM should be heated in accordance with a specific time-temperature schedule that achieves a minimum wood core temperature of 56 for a minimum of 30 minutes.</b></li> </ul> <p><b>WPM has been treated by the approved measures</b></p>	<p><b>The following WPM are not regulated by this requirement:</b></p> <ul style="list-style-type: none"> <li>• <b>The thickness of WPM is less than 6 mm.</b></li> <li>• <b>WPM is glued by heat and pressure.</b></li> <li>• <b>WPM has been treated by paint or stain.</b></li> <li>• <b>WPM has been treated by tar or other preservatives.</b></li> <li>• <b>Cask with wine.</b></li> </ul>

The specified mark is shown below:</p>  <p>The mark should at minimum include the:</p> <ul style="list-style-type: none"> <li>o IPPC symbol, XX (ISO two letter country code), 000 (a unique number assigned by the NPPO to the producer of the WPM who is responsible for ensuring appropriate wood is used and properly marked) and YY (the approved measure used: MB - methyl bromide fumigation; or HT- heat treatment)</li> </ul> <p>WPM which does not carry the required mark would be returned or treated by MB fumigation or heat treatment mentioned above. The plant quarantine authority would request the goods with their WPM be returned in the following situations:</p> <ul style="list-style-type: none"> <li>o The WPM is too large or for some reason can't be treated under the treatment facility in existence.</li> <li>o The WPM and the goods could not be separated and importer does not agree to joint treatment.</li> </ul>
